**SICSA is again proud to be participating by offering  
 \$30 Female Cat Spays on Sunday February 19th**

**All cats 4 months or older must also have a rabies vaccination for an additional \$10**

**SICSA is offering female cat spays for \$30 for those qualifying for our low income program. (See guidelines below) In addition clients must have their cat's rabies vaccination done for an additional \$10 if 4 months or older and not current. Clients must complete an application (may be printed from our website), show proof of income and send in the appropriate payment (\$30 for female cat who is current on rabies vaccination - \$40 for female cat who is to be spayed and receive her rabies vaccination) Once we have received your completed application and payment THEN your appointment will be scheduled.**

If you do not qualify for our \$30 female cat spay special SICSA does offer the following spay/neuter program the entire year. If your income is over these guidelines but you are interested in neutering feral or stray cats, please contact Zandra at (937) 294-6505 x 16 to discuss available options.

All Females: Cats and Dogs will receive **at no charge** a permanent marking of the surgery incision or client may choose ear notching also at no charge (cats only). All Male adult Dogs will also receive this permanent marking **at no charge**.

This marking can help identify your pet as already having been spayed or neutered; client may specify no marking if having pet micro-chipped at above listed fee.

**BASIC INFORMATION**

SICSA offers FVRCP/DHPP vaccinations for \$15 at the time of surgery. If your pet has not had prior vaccinations, for better immunity it is recommended that you have a second vaccination completed in three weeks at your vet. Rabies is the only required vaccination but we strongly encourage that all vaccinations be current. Surgeries are done at SICSA. The day of surgery you will arrive between 7:30 and 8:15 a.m. for check in of your pet (please allow 45 minutes). Your pet will be ready to go home later in the day: normally between 4:00 & 5:00 pm. SICSA also performs pediatric surgeries – your pet may be spayed or neutered as young as eight weeks of age. (Puppies coming through the pediatric (“Baby Fix/B4 4 months) MUST have at least one DHPP vaccination prior to surgery) **\$20 Reschedule Fee if appointment changed less than 72 hours prior to surgery appointment. Please arrive and pick up at your scheduled time – a late fee may be charged if arriving or picking up after scheduled time.**

**PROOF OF INCOME and PAYMENT MUST BE SUBMITTED WITH YOUR APPLICATION – THEN YOUR APPOINTMENT WILL BE SCHEDULED**

Proof of income: Income Tax copy; W-2; Social Security (Direct Deposit Statement); SSI; or Food Stamps

On our “special” Spay/Neuter Days – due to the number of surgeries performed – appointment times will vary from our regular check in and pick up times.

We must have your completed application, proof of income and payment BEFORE your appointment will be scheduled. Application may be printed from our website [www.sicsa.org](http://www.sicsa.org) or you may come to SICSA to complete your application and pay.
